If a Chemical Spill Occurs

- ◆ Notify the office immediately of a hazardous material spill.
- ◆ Share any information with the office, such as the chemical type, and if there are any known injuries.
- ◆ **DO NOT** try and clean up the spill unless you are trained to do so and have proper equipment.
- ◆ If possible, control access to the affected area by closing doors and blocking off hallways.
- ◆ Report to the principal any student or staff member that shows adverse medical symptoms such as shortness of breath, vomiting, or fainting. Refer to the medical emergency tab if necessary.
- ◆ The principal/administrator will call 9-1-1 if necessary and notify the custodial/maintenance staff.
- ◆ The principal/administrator will notify the Superintendent.
- ◆ If the principal/administrator advises the student and staff to either evacuate or relocate, follow appropriate emergency procedures. Teachers should bring their student rosters and take attendance at the assembly area to account for students.
- ◆ Report all missing students to the Student Services Office.
- ◆ Do not return to your classroom or office until the principal/administrator provides and "ALL CLEAR" announcement.

If you Suspect a Natural Gas

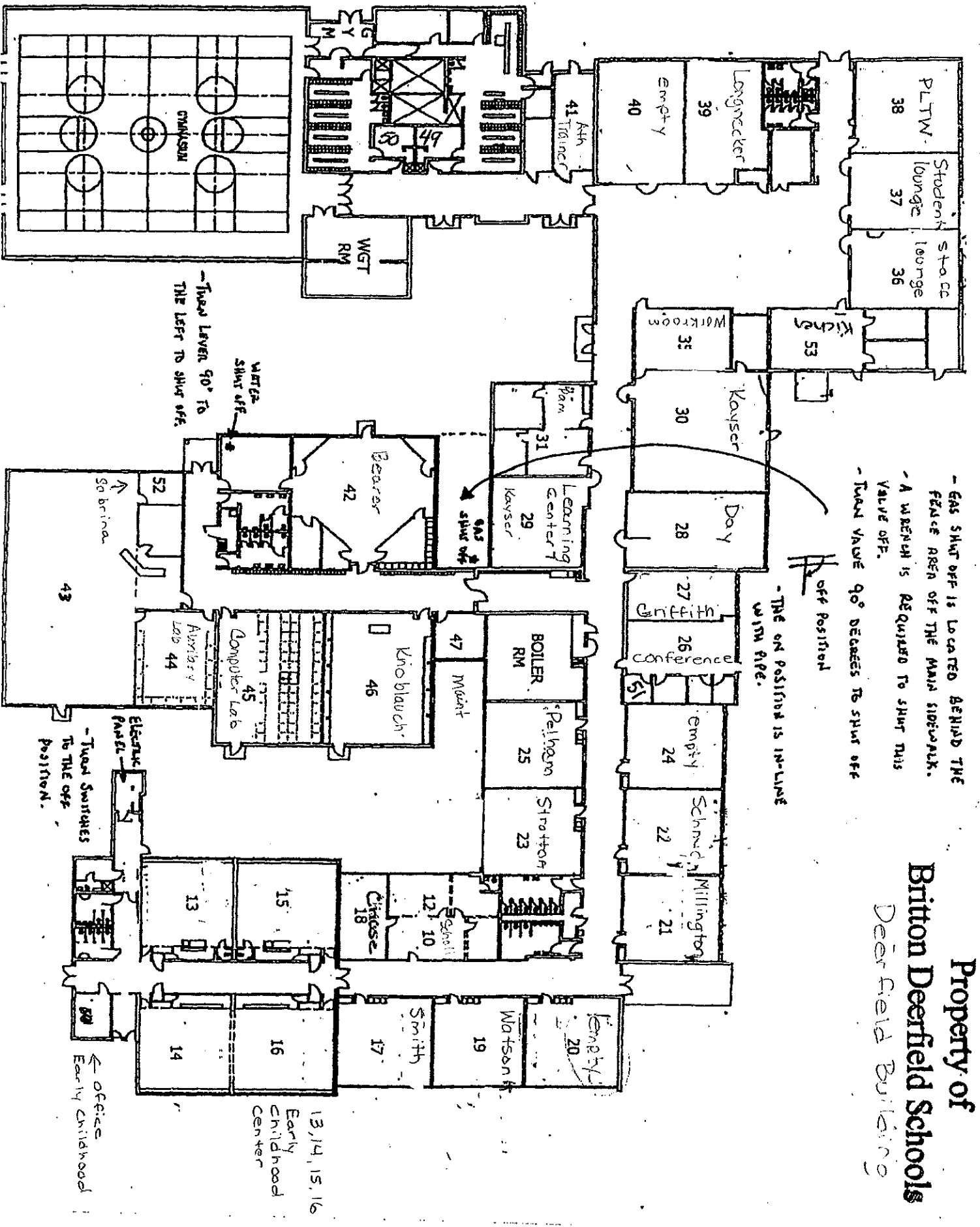
- ◆ Evacuate students out of the area immediately; go directly to the area.
- ◆ Alert the Office and other classrooms of the leak on your way.
- ◆ At the assembly area, take attendance and report any missing to the Student Services Office.
- ◆ **DO NOT** try and locate the leak.
- ◆ **DO NOT** use any electrical devices, such as light switches, telephones, or appliances.
- ◆ **DO NOT** use an open flame, matches, or lighters.
- ◆ **DO NOT** try to shut off any natural gas valves.
- ◆ From a safe location—call 9-1-1.
- ◆ **DO NOT** reenter the building until an "ALL CLEAR" is announced.

Signs of a Natural Gas Leak

- ◆ "Rotten egg" smell.
- ◆ Dead or discolored vegetation in an otherwise green area.
- ◆ Dirt or dust blowing from a hole in the ground.
- ◆ Blowing or hissing sound.
- ◆ Flames, if a leak has ignited.
